THREE ALASKA LONG TRAIL PROJECTS SURVIVE BUDGET PROCESS


Great news for trails this summer! On June 19th, Governor Dunleavy enacted the FY2024 state budget, and THREE Alaska Long Trail projects totaling \$1.434 million are in it, thanks to an amendment submitted

by Senator Wielechowski and support from Senator Merrick and Representative Saddler!

The three projects are in Chugach State Park:

Alaska Trails is the funding recipient for all of these projects and will be working closely with the Chugach State Park's staff and local contractors over the next couple of years.



We are excited and grateful to see funding for trails in the state capital budget for two years in a row now. This support in the bipartisan state legislature and Governor's administration is a testament to the economic viability of the long trail concept and to the importance of specific trail segments to communities. Each of the funded projects will bring economic and health benefits to local residents but will also contribute to the growth of statewide outdoor recreation economy in the heart of Alaska.

DO GOOD FOR YOURSELF AND OTHERS WHILE OUT USING THE TRAILS

When you are out enjoying the trails, remember that you can be a force of good. That starts by acting responsibly: respect private property, don't shortcut switchbacks, keep your dog under control, be quiet around homes. But you can do more than that. You can also be the eyes and ears for the community. If you see a problem with a trail, a problem with wildlife, or something suspicious, please report it.

Trail apps sometimes have a way to report an issue with the trail. For example, with OuterSpatial (https://www.outerspatial.com/), which is used by several agencies in Alaska, users can report issues on specific trails. LAWSUIT OVER STEWART TRAIL ACCESS OFFICIALLY FINISHED

The long, drawn-out lawsuit over public access to the Stewart Public Trail is finally done. See this letter from the Friends of the Stewart Public Trail:

The litigation is now officially over. The defendants paid the legal fees they owed us, and this was used to pay our lawyers for the past work they had done. With that, all legal matters have been resolved.

The only remaining issue is to figure out parking, which we will do with the Municipality in the coming weeks. We will keep you updated on those developments.

This has been a long, costly effort, but the outcome was very successful. A huge part of the achievement was due to the community support we were able to focus and unleash.

Very rarely in life do we get to create a direct connection to future generations. This was one of those occasions. We should feel very good knowing that we have preserved a beautiful piece of earth for the public for eternity. Please exercise wise custodianship of the trail.

CHUGACH MOUNTAIN BIKE RIDERS


June 7: Has any group come up with trailbuilding design parameters for winter fat biking? We're planning new "multiuse" trails, but our primary design consideration is to fit a pisten bully groomer down them for winter use - the XC ski trails are ski only and the mushing trails are mushing

only, so these will be designed as beginner fat bike trails open to everyone.

However, we also want to harden the trail with crushed gravel for summer use, and find that XC ski and dog mushing grades are too steep for gravel retention, and for beginner fat bikers, who end up walking the hills, wrecking the groom.

Here's the specs so far: 12' clearing, 8' e-1 gravel (4" deep d-1 with fines - 2' dirt shoulders @3-5%). Average

trail grade 5% with a short pitch max of 8% (really shooting for 7%, but 2%-8%).

However, the access to Gnarski n' Hucks via the new Field of Dreams trail is a glorious two way trail which allows access to the top of the trail system with a flowy fun descent that is wide enough for two bikes to pass in most spots.

All trails at GPRA are running great right now, so get out and enjoy!

FAIRBANKS COMPREHENSIVE TRAIL PLAN UPDATE PASSES

In June, the Fairbanks Borough Assembly passed the Comprehensive Recreational Trail Plan update – almost fully intact and by a 7-2 vote.

A last-minute compromise deal devised by Assemblyman Aaron Lojewski, and then refined by Mayor Bryce Ward and his staff, assuaged most of the private property concerns of several assembly members. In the end, only Assemblymembers Barbara Haney and Brett Rotermund voted against the plan update. And during comments at the end of the meeting, Assemblyman Rotermund said he was pleased to

see the compromise work.

"Even though I stuck to my 'no' vote, I'm pretty happy this thing passed," he said.

To get the compromise, the plan update was changed in two significant ways.

- The definition of C trails was changed so that it now gives borough staff more latitude to expend resources on those trails.
- Several trails new to the plan were reclassified from A and B trails to C trails.

CHALLENGE OFFERS OPPORTUNITIES TO FIND TRAILS IN INTERIOR

The Fairbanks Summer Trails Challenge is live with 20 signs up and ready to find all over the borough.

The challenge started June 20 and lasts until September 30.

There are again three award categories: Trailblazer, Junior Trailblazer, and Sourdough Trailblazer. Trailblazers are 10 years old and up and must find at least 10 signs. Junior Trailblazers are up to 9 years old and must find five signs. Sourdough Trailblazers are at least 60 years old and must find five signs.



This event, put on by the Fairbanks
North Star Borough Parks and Recreation
Department, is an all-ages, all-abilities,
outdoor scavenger hunt. The challenge is
designed to get you out with your friends
and family to explore our wonderful local
trails, both new and familiar.

Anyone is allowed to participate in the search. When you find a sign, mark it off on your checklist, which you get when you register. You no longer need to prove you nabbed a sign by taking a selfie, but participants are still encouraged to take the photos and post them on social media with the hashtag "#FNSBTrails". Putting it on

the Trails Challenge Facebook page is a great way to share. And of course, leave the sign to be found by the next trail challenge participant.

Participants who find the minimum number of signs for their category get their official award and can win prizes from local sponsors. Whether you find one or find them all, challenge yourself to get outside and enjoy nature!

BLM DENIES PERMIT FOR HELICOPTER DAY TOURS AT TOLOVANA

The Bureau of Land Management (BLM) has denied a permit for day tours at Tolovana Hot Springs that would have included helicopter landings. The decision was made on May 4. A public release announcing the decision was dated May 24. Below is from the decision statement:

A field inspection was conducted by BLM staff in mid-February, 2023, which illustrated a number of issues with the proposal for which no reasonable mitigations could be identified. The rationale for denial included increased noise and reduced bather privacy resulting from the proposed action that would likely create recreation conflicts and diminish user experiences of Tolovana Hot Springs Ltd guests. Other issues noted were a lack of sufficient water flow and water temperature



from the seeps near the proposed tub location to support the proposal, and safety concerns arising from helicopter operations in close proximity to public recreational use. Due to the decision to deny the permit for the above stated reasons based on a field inspection by BLM staff, an environmental analysis was not completed.

According to the proposal submitted late last year, a hot tub would have been brought in for the operation and tours would have been done via helicopter with a maximum of three landings per day.

PRIVATE DONATIONS IMPROVE DOG MUSHING TRAILS

Several miles of Alaska Dog Mushing Association trails were improved earlier this year thanks to two \$20,000 private donations from the Interior Alaska Trails and Parks Foundation.



The trails were mowed and mulched, which levels the trail by trimming tussocks and stumps. This helps make grooming easier, especially early season grooming when uneven trails can make for a wild ride for groomers. The mowing also helps improves sight distance around corners.

About 14 miles of trail were mowed, making up nearly half of the total ADMA trails. The bulk of the work was done in May, though some mowing was done last fall. Much of the work was done on the Creamer's Field Migratory Wildlife Refuge. The Alaska Department of Fish and

Game, which manages the refuge, oversaw the work.

Funding for the project came from a private endowment. The work was done by Greenstone Station, a Fairbanks-based business. The company owner, Shaun Patterson, built Shaun's Trail at Pearl Creek Nordic Park as an Eagle Scout project and also mowed the "ski field."

Organizers hope to continue mowing and mulching more of the trails next spring.

BOROUGH SEEKS COMMENT ON COMPREHENSIVE ROAD PLAN

COMMENT The Fairbanks Borough is seeking comments on its Comprehensive Road Plan. This process has been underway for a while. They took comments last year and now have a revised plan that is available for review and comment. While the people working on the Road Plan worked closely with those on the Comprehensive Trail Plan, trails advocates should still look closely at the revised road plan. Look for conflicts with roads and trails. Make sure your voice is heard.

Please note: THIS IS JUST A PLAN. It is a guiding document for where roads should go IF AND WHEN they are built. This does not mean the borough is going to start building all these roads right away. (The borough will not build most of the roads on the plan, maybe none.)

This is a good approach to development. While there may be some road/trail conflicts with the revised plan, it is better to get these issues figured out early and with some thought to how everything is integrated.

June 4: Randy (VP) and Brian (Treasurer) went out to trim up Table Top Mountain Trail today.

We knocked back the dwarf birch with hedge trimmers from the alpine area to below the boardwalk (about a mile and cleaned up fallen trees and new growth to the trailhead covering 2 miles). Tough work for sure!

The eastern side of the loop has not looked this good in decades!

Lots of water on the trail. Snow still blocks the top from easy access. Spring is just coming to Nome Creek! Let us know what you think of the trail!

SKARLAND & PEARL CREEK TRAIL USERS

Stan Justice, June 26: I have been out benching another section of the Skarland that is hard to groom because the side slope is so steep that the snowmachine wants to tip over and the drag tracks low. As you use the reworked section try to stay on the high 1/3 of the trail. The high 1/3 is the cut bench so naturally compacted Loess. The middle third is boot packed loess and the lowest third is where I toss the duff and roots. The lower side of the trail will revegetate if we keep traffic off.



I have done a lot of digging along the Skarland and only in this area found buried pebbles. They seem to be buried 4-5 inches deep. I understand loess accumulates at a rate of an inch every 1000 years. By what process did these pebbles get incorporated into the loess thousands of years ago? Location is above Red Fox Rd. near the tire swing.

Stan Justice; June 14: I attended the Joint Mobility Task Force, a group of DOT, Cities, and borough folks with BPAC (Bicycle Pedestrian Advisor Committee). The BPAC is part of FAST Planning and advocates for bikes and pedestrians. On the agenda was the Skarland Trail issue at Ballaine and Yankovich where the path gets obstructed every winter by loader over clearing the road. 


JUNEAU PARKS & RECREATION

The CBJ is working in cooperation with the United States Forest Service and Federal Highway Administration to complete the study. The work is being funded by the Federal Lands Access Program. The planning process begins with a survey and will include additional public involvement, with the goal being a conceptual reconstruction plan for the trail.
