


adventures, and life in general. Our 2024 Trail Tales events will be held at the Anchorage Museum and tickets cost \$20.

VIRTUAL RACE ACROSS ALASKA BENEFITS YOU AND ALASKA TRAILS

ENTER/DONATE The Race Across Alaska Winter Challenge, a multi-sport challenge, is a great way to get



outside while challenging yourself to stay happy and healthy during winter. And you can also be helping our cause to help build and maintain some of the best trails in the world!

Here's how it works. You can run, walk, fatbike, indoor bike, XC ski, swim, or any activity you like. You can choose from eight different virtual distances – from 60 miles to 2,000 miles, which is a whopping 22.3 miles per day. Now that's a challenge. The goal is to log as many miles as you can over the three months of winter to get (virtually) from location A to B. You can also participate as a team (friends/family/school).

You will have the ability to log your miles, track your progress, collect virtual badges, and see how you rank up to others on the leader board daily. You can invite others to this challenge to help you to stay motivated all winter long.

Looking Back, Looking Forward Grateful Either Way



We are grateful for many things as we head into the heart of winter. Looking forward to a bright 2024, we look back at 2023 with fond memories of trail projects, volunteer events, and significant progress on the Alaska Long Trail. Alaska Trails is excited to be part of the community that is building, maintaining, and promoting trails across our great state.

Race Across Alaska Winter Challenge

Staying mentally and physically healthy can be challenging during this dark time of the year. Recreating on trails helps bolster our physical and mental health. From hunting to fatbiking to strolling with family or running with friends – trails are great way to get outside.

One great way to get inspired to stay healthy is through the Race Across Alaska Winter Challenge (RAAWC) – Online registration began in November and the virtual race starts on the Winter



Solstice – December 21. The RAAWC is a multi-sport, multi-distance winter challenge with the goal to log as many miles as you can over three months. It's a great way to stay active during the winter. You can walk, run, fat tire bike, trainer bike, cross-country ski or swim.

The **RAAWC** is also a fundraiser for the Alaska Long Trail project. It has raised over \$120,000 for the ALT in just three years! For every participant, \$10 will be donated to Alaska Trails **PLUS** racers can donate

additional funds to support the development of the ALT. Alaska Trails is grateful for the financial support from the race, but we also appreciate how it inspires an active, healthy lifestyle. This year, two other nonprofits are also beneficiaries – Challenge Alaska and the Nordic Skiing Association of Anchorage (NSAA). We are excited and honored to be partnering with them.

Looking Ahead to the 2024 Season

We are prepping for a great 2024. Alaska Trails staff have been meeting with land managers, such as

Chugach National Forest and Chugach State Park, to plan projects both for our paid trail crews and our volunteer events. We are excited to help land managers build and maintain trails in 2024 and beyond.

This work is due to your support. We are grateful to all our financial donors – especially our 325 Pick. Click. Give donors, who donated over \$21,000 this



year. There are many great non-profits in Alaska, and your support means so much to us.

The Alaska Long Trail

Alaska Trails is looking forward to continuing work on the Alaska Long Trail in 2024. Alaska is long overdue for this type of world-class hiking trail and the economic diversification it will bring to our state. Alaska Trails worked together with partners to secure funding for the Alaska Long Trail in the FY2024

state capital budget, and Governor Dunleavy approved \$1.434 million for three projects in Chugach State

Park. This is in addition to the \$4.22M secured in FY 2023.



We are ready to continue the work of securing the rest of the funding to be able to connect 500+ miles of Alaska via a sustainable and exceptional trail system. Alaska Trails will continue to work with its partners to highlight the great trails on the Long Trail route that already exist and to connect the dots to make this expansive vision a reality.

In this holiday season, we wish you health and good times AND we hope some of those times will include some fun trail adventures.

STATE PARK PASS PRICES TO GO UP, 2024 PASSES AVAILABLE NOW

Alaska State Parks annual parking passes can be purchased beginning Nov. 15, and are good to the end of 2023 and throughout 2024. A price increase for the 2024 calendar year will go into effect on Jan. 1, 2024.

A Division of Parks & Outdoor Recreation (DPOR) Director's Order beginning in January includes moderate fee increases to the annual parking pass, day-use parking, permits and some State Parks cabins

throughout the state. The additional revenue will go to the division's budget to help maintain Alaska State Parks facilities and support outdoor recreation in Alaska.

"Since prices go up at the beginning of the new year, we expect to sell a lot of 2024 passes prior to that – so don't wait to get your pass," warned Director Ricky Gease of the Division of Parks & Outdoor Recreation. "When you consider how many outdoor experiences you can squeeze into an entire year, the annual Alaska State Parks pass is quite a deal. It's also a great holiday gift!"

2024 Annual Parking Passes can be purchased for \$60 until Dec. 31, 2023 at:

- https://dnr.alaska.gov/parks/passes
- DNR Public Information Centers in Anchorage and Fairbanks
- Retailers throughout the state (including REI in Anchorage, one of the most popular places to get the pass) by Nov. 30

On Jan. 1, 2024, the cost of the pass will change to \$75. The 2024 passes have been honored since November 15 at all DPOR-managed parking areas. Parking areas at Pillars Boat Launch, Arctic Valley,



Eagle Rock Boat Launch and Eagle River Nature Center are not covered by the parking pass and fees must be paid directly to the managing organization.

The 2024 Boat Launch passes will also be available on Nov. 15, priced at \$150 each. Disabled veterans with appropriate documents can obtain a Disabled Veteran Camping Pass, good for five years, at no charge.

STATE BOARD TO REVIEW RTP GRANT APPLICATIONS



RESOURCES HELP REDUCE PET/TRAPPING CONFLICTS

Trapping season opens November 1, so trail users who let their dogs run loose should make sure they

know some basic information about traps and trap lines. A pamphlet and videos are available.



<u>PAMPHLET</u>: A pocket-sized pamphlet titled "Trap Safety for Pet Owners" describes the types of traps and snares that may be encountered and provides illustrated instructions on how to free pets swiftly and safely. It is produced by the Alaska Department of Fish and Game (ADF&G) and the Alaska Trappers Association (ATA). Copies are available free of charge at department offices or may be viewed on the website at: http://tinyurl.com/m6oulhk. More information, including video footage featuring trap removal instructions, is found on the department's website at www.adfg.alaska.gov (see "Sharing the Trails" under the

"Hunting > Trapping" dropdown menu),.

<u>VIDEO</u>: The ATA also sells a 30-minute video, "Sharing Alaska's Trails," that includes information such as how to know if you are on a trap line, trap line safety, the physics of handling and opening traps and



snares, and tips for first-aid for pets accidentally caught in traps. The video doesn't promote trapping but deals with the practicalities of sharing the trails. A three-minute excerpt of the DVD can be found on YouTube (www.youtube.com/watch?v=Jk242jZwEAQ). To order a copy of the DVD check the ATA store (www.alaskatrappers.org).

Most trapping seasons run from November 1 to the end of February, but the season for a few species lasts longer. Wolf traps could be active well into April.

ACTION NEEDED TO HELP SLOW CLIMATE CHANGE

COMMENTS SOUGHT FOR E-BIKE AMENDMENT FOR CAMPBELL TRACT

The deadline is December 14 for comments on the Proposed Ring of Fire Resource Management Plan Amendment for the Campbell Tract final environmental assessment and unsigned Finding of No Significant Impact (FONSI).

The proposed amendment would allow for class 1 electric bikes (e-bikes) on trails in Campbell Tract. The BLM developed this proposed amendment and environmental assessment with public input



received through a listening session, a 30-day public scoping period, and a 30-day public comment period on the preliminary environmental assessment. Through these engagements, the BLM received 184 comments that helped inform the process.

During the protest period, anyone who has participated in this process and has an interest that is or may be adversely affected by the planning decisions may protest approval of these decisions. BLM's webpage provides detailed instructions (https://tinyurl.com/yc7xc75z) for how to file a written protest to the BLM Director, which can be done in hard copy to the one of the below addresses

or electronically on the BLM's ePlanning website by clicking the green 'File Protest' button by the Final EA document.

The trail is closed annually between late summer and winter freeze-up to reduce the potential for human-bear encounters.

Although the trail has been reopened, bear encounters are still possible and trail users should take appropriate precautions. Be prepared to encounter a bear and be knowledgeable in recognizing bear behavior and responding to an encounter.



Of the 100 nonmotorized projects budgeted for the 2050 MTP (Metropolitan Transporation Plan), 99 are in the Anchorage Bowl. It is a reasonable request to amend the plan to include a second Chugiak-Eagle River paved pathway.





FEDERAL HIGHWAY FUNDING OPPORTUNITIES TABLE UPDATED

The Federal Highway Administration (FHWA) updated the Pedestrian and Bicycle Funding Opportunities Table. See https://www.fhwa.dot.gov/environment/bicycle_pedestrian/funding/funding_opportunities.pdf. If you see the September 2022 version, then your computer cached the old table. Refresh (perhaps several times, and/or delete your cache), and you should see the November 2023 version.

The table is public information. You may share with anybody who wants to know about Federal funding for pedestrian, bicycle, and trail programs and projects.

Revisions include:

- Reorganized the program order.
- Added the Active Transportation Infrastructure Investment Program and SMART Programs.
- Included the Neighborhood Access and Equity Program eligibility under Reconnecting Communities.
- Removed the FTA Associated Transit Improvement program (the requirement was repealed).
- Added activity or project types:
 - Charging stations for electric bicycles and scooters
 - Encouragement and education activities
 - Public education and awareness programs
 - Technical assistance
- Revised a few categories:

- Several project types added eligibility for electric outlets and charging.
- Landscaping: added shade trees.
- Resilience, Spot Improvements, Stormwater: revised for clarity.
