
GENEROUS DONOR GIVES PICKUP TRUCK TO ALASKA TRAILS

Alaska Trails is grateful to Anchorage resident Thomas Pease who recently donated his GMC truck to Alaska Trails. We plan to use the truck for our Youth Employment in Parks (YEP) collaboration. This dependable truck is ready to carry a heavy load and pull a big trailer. The donation will save Alaska Trails \$1200 a month next season as we will not have to lease a truck for the YEP program. BACK TO ALASKA LONG TRAIL NAME, ALASKA TRAVERSE ON HOLD

In August 2023, the Alaska Long Trail Coalition switched the name of the Alaska Long Trail project to the Alaska Traverse. However, the Coalition has since learned that the project would benefit from keeping its old name, which has been used over the past three years. The trail has an opportunity to be designated as



a National Scenic Trail, and keeping the old name will greatly increase chances of success of this designation.

With the help of Senator Murkowski (THANK YOU!), the Congress recently directed the Bureau of Land Management (BLM) to conduct the National Scenic Trail feasibility study for the "Alaska Long Trail," and this language is now part of the National Scenic Trails Act. This means that the BLM will have to refer to the project under that name for the duration of the study, which can take three or more years (average is seven).

After considering the implications of keeping two names for the same project over the next three or more years, it has become clear that this situation would create confusion and possibly pushback, jeopardizing not only the success of the National Scenic Trail feasibility study but also other funding opportunities (state capital budget, federal appropriations, etc). Alaska Trails and partners want to maximize the success of the feasibility study and minimize the confusion about the name of the project, and that's why the project name is going back to the Alaska Long Trail. At the end of the feasibility study, there will be an opportunity to work with the BLM on a different name for the project, and that

would be the time to suggest the change to the Alaska Traverse or another option.

The National Scenic Trail (NST) system comprises 11 long trails around the country, including the Appalachian Trail and Pacific Crest Trail. The NST designation opens doors to more federal funding in the future and will be critical to the development of the Alaskan long trail. The designation would also bring more nationwide recognition, leading to increased visitation and business to communities along the route. The NST designation does not set restrictions to specific trail use (motorized can be included), and decisions on the trail use are left with land managers such as municipalities, boroughs, and state and federal agencies.



"When Galen Hecht moved from Santa Fe, New Mexico, to Anchorage, locals teased that he hadn't really moved to Alaska; he'd moved to a city adjacent to the "real" Alaska. But he quickly realized that Anchorage is largely made up of outdoor space. Three-quarters of residents live within minutes of one of its 200plus parks, and those green spaces are linked by a 500-plus-mile trail network. According to the Anchorage Park Foundation, 95 percent of residents say the trail system—which includes 120 miles of multi-use paths, 105 miles of maintained cross-country ski trails, 87 miles of hiking trails, and 36 miles dedicated to dog mushing—helps make this a great place."

RECREATIONAL TRAILS PROGRAM APPLICATIONS DUE IN OCTOBER

APPLY It's time to get your Recreational Trails Program grant application finished up.

RTP grants provide reimbursable, matching funds to develop and repair recreational trails and trailrelated facilities for both non-motorized and motorized recreational trail uses. Grants are also available for trail-related environmental protection, safety, and educational projects. The grants are administered through the Division of Parks and Outdoor Recreation. The timeline is below. Questions? Contact the State Trails Coordinator at (907) 269-8699.

- September 30, 2023: The mandatory public notices must be posted by this date.
- October 31, 2023: Applicants must submit their application electronically and/or by mail on a USB flash drive. All applications must be received electronically or postmarked by this date.

SNOWMACHINE GROOMING PROGRAM CHANGES DEPARTMENTS

The SnowTrac Program, which provides funding for snowmachine trail grooming, has been moved within the state government. For details, see the following email.

As of July 1, 2023, the administration of the SnowTrac Program has been transferred from the Department of Natural Resources (DNR) to the State of Alaska Department of Transportation (DOT&PF). The transfer of this program will allow the DOT&PF to explore options to enhance the program funding and eligibility projects for the grantees through leveraging other potential funding sources and partnerships.

The DOT&PF will administer the grant program with a focus on continuing to provide reimbursable grant funds for development and maintenance of trails and trail-related facilities for Snowmachine use.



Snowmachine trail grooming activities are only provided through the program's Grooming Pool. The Grooming Pool is a program that distributes grant funds for grooming, marking, and signing snowmachine trail systems. The program offers the flexibility to use funds where trail grooming is needed around the state.

The Snowmachine Trail Grant Program uses Snowmachine registration fees to support a system of groomed Snowmachine trails in several regions of the state. Funds are used by Snowmachine clubs, non-profits, and businesses to groom and mark trails.

Trails must be legal and approved by the Snowmachine Trail Advisory Council (SnowTRAC). More on this soon!

We are close to stabilizing the program (internal administration details on the transfer and program set up) and preparing an announcement for FY24 funding. I believe I captured all recipients from last

year on this email chain, if I missed anyone, please forward this information on and provide my contact details.

I will let everyone know when the new program website is published and grant application is ready. Our plan is to follow the same timeline as last year when the program was administered via DNR.

CENTRAL HUBS OFFER TRANSPORTATION FUNDING OPPORTUNITIES

The State of Alaska Department of Transportation and Public Facilities has two information hubs of interest to trail users and managers.

Transportation Funding Opportunity Hub

The Alaska Transportation Funding Opportunity Hub provides public access to state programs and federal

grants that are available to Alaska communities to support transportation improvement across the state. The clearinghouse additionally provides a dashboard of projects that have been submitted for various funding programs. These opportunities include state regulated funding programs such as Transportation Alternatives Program (TAP) and Community Transportation Program (CTP), as well and federal Notice of



Funding Opportunities (NOFOs). The goal is to corral all the opportunities into one place and help you identify those that are a best fit for your projects.

LWCF GRANT APPLICATIONS DUE BY END OF OCTOBER

APPLY Application packets for Land and Water Conservation Fund (LWCF) 2024 grants were available starting August 1.

The Alaska Division of Parks and Outdoor Recreation (DPOR) administers this competitive reimbursable grant program in partnership with the National Park Service. LWCF can provide up to 50% of costs for eligible outdoor recreation projects. An estimated \$1 million in LWCF federal funding will be available in this grant round. Eligible applicants include state, regional, local and tribal governments with the legal authority to provide park and recreation services on public lands. Applications will be accepted by DPOR from August 1 through noon on October 31. LONG-RANGE ANCHORAGE TRANSPORTATION PLAN INCLUDES TRAILS

COMMENT The Metropolitan Transportation Plan (MTP) is the primary tool used by the Anchorage Metropolitan Area Transportation Solutions (AMATS) to plan for long-range transportation needs and recommend solutions based on anticipated funding availability over a minimum 20-year horizon. The MTP includes the whole transportation system in the Anchorage Bowl and Chugiak-Eagle River: streets, sidewalks and pathways, trails, public transit, freeways, highways, and freight mobility. The DRAFT 2050 Metropolitan Transportation Plan has been released for a 60-day public comment period through October 9. Indian Valley Trail is in rough shape: there is mud and wet brush, and Indian Creek has changed its course in several sections. Two of our primary bridges were washed out or gone completely, and there are landslides.

Professional opinion: The trail should be considered impassable in its current state.

The good news is that Alaska Trails recently received CAPSIS funding to make improvements to this trail, which should be implemented in the next year.

This means that you will no longer be able to walk along the section line that took you to Dorothy Drive. The Alaska Department of Natural Resources (DNR) reversed their denial of this vacation (7/1/2020) on appeal by the petitioners (EV 3-299).

Please respect private property, do not trespass. We are disappointed in this action by DNR but hope you will join us next summer as we brush out the new pedestrian easement granted by John Fowler. The Rim trail will cut to the east from the old trail into some delightful meadows s.

FOREST SERVICE ISSUES POINT LOUISA TRAIL DECISION

The Juneau District Ranger has signed the Decision Memo for the Point Louisa Picnic Site and Trail Project, which authorizes the construction of a 225 square-foot gravel pad and 670 feet of trail improvements at Point Louisa in the Auke Village Recreation Area in Juneau, Alaska.

The trail begins at the Auke Village Campground and travels south for approximately 0.2 miles. Prior to Forest Service stewardship, the Auke Village Recreation Area was occupied by the Áak'w Kwáan people and is culturally significant. Construction activities for the gravel pad include importing gravel, a metal fire ring, and a picnic table.

For the trail, imported gravel will be used to harden an already existing social trail. A small excavator may be used to place large boulders for seating around a fire ring.

These improvements are needed to help ensure the protection, and sustainable use of a popular recreation location.
