Molly Redilla – Fairbanks

Molly Redilla moved to Fairbanks to lead environmental sampling across the taiga and tundra and has been here since. Currently, Molly serves as the Vice President of Lands for Doyon, Limited, which is the largest private landowner in the state. She is responsible for the management of Doyon's Alaska Native Claims Settlement Act lands. Molly earned her Bachelor of Science in Fisheries and Wildlife with a concentration in Wildlife Biology and Management and a Doctor of Philosophy in Forestry and Spatial Ecology from Michigan State University. Molly was a Postdoctoral Research Fellow at North Carolina State University where she researched ways to help stop the spread of the most invasive forest insect in North America to date. She has spent years studying and researching forest health and ecology and modeling landscape changes across space and time. She has devoted her career to understanding the land we live on and determining ways we can help manage it. Outside of this, she is an avid trail user and spends as much time as possible in Alaska's wilderness.



Susan Lagrande - Anchorage



Susan LaGrande is a long time Alaskan, an artist, an educator, and a retired psychologist. She arrived in Alaska as an east coast city person who cared little for the out of doors. The turning point for her was a hike North of Livengood, when looking out over the vastness, realized the shear beauty and power of nature. She views access to trails as an opportunity to connect community and inspire protection of the environment. She spends as much time as possible hiking, biking, snowshoeing, and paddling a kayak. Summers are spent exploring coastal Alaska on a boat.

LEARNING FROM THE PROFESSIONAL TRAIL BUILDERS CONFERENCE

Ben Ervin, our Trails Program Officer, recently attended the Professional Trail Builders Association Sustainable Trails Conference in Lanier Islands, Georgia. We sent Ben down to get a picture of where the professional trail building industry is at currently and where it is headed in the future.



Ben joined more than 300 trail professionals at the conference, which had more than 40 concurrent sessions, roundtable discussions, and hands-on learning opportunities. Ben attended as many as he could and learned about a variety of subjects, including trail math, efficient use of helicopters, mechanized equipment, renovation of extremely eroded trails, strategies and challenges in finding/training/retaining crew, flow trail, and trail counters.

SPRING TRAILS ARE VULNERABLE, PLEASE USE WITH CARE

TREAD LIGHTLY Alaska Trails asks that you please keep in mind how your trail activities might affect other trail users, especially in the spring.

As snow melts and the ground thaws, the trails become extremely muddy. Using muddy trails at this time can result in ruts that stay all summer when the trails dry out. Those ruts can make the trails difficult to use all summer and into the next winter. They help create erosion by keeping water on the trails.

But with a little thought this problem can be greatly reduced.

- Try to be patient. Stay off the trails if you can. If you are unsure if a trail is ready to be used, check it out with the commitment to turn back if you are doing too much damage.
- Choose low impact. If you use the trails in several different ways, choose the method of travel that will cause the least amount of damage if you do run into some muddy sections.
- Pick your trails carefully. Use well-drained trails with lots of southern exposure. They typically dry out
 the quickest. If you just have to get muddy, please limit your activities to trails that are already
 thrashed.

An alternative to using trails in the spring is to get out on foot or by bike and go explore quiet subdivision roads new to you. Alaska Trails is grateful to be a National Forest Foundation grantee in the Chugach National Forest! These



funds have been used to restore and improve sections of the Iditarod National Historic Trail and the Johnson Pass Trail. An Alaska Trails crew brushed the trail corridor, reworked approximately 1,200' of natural surface tread, removed 100' of berm that was causing the trail to be concave and hold water, and cut roots intruding into the tread on one mile of trail for better ATV and machine access. In addition to these improvements, this crew fell over 20 hazard trees, installed a culvert for improved drainage, and installed a turnpike to give trail users a dry and

sustainable walking surface.

This work greatly improved the trail user experience by helping clear a wider corridor for improved sightlines; by improving the drainage, preventing the tread from getting overly mucky, even during the rainy season; and by eliminating many overhead hazard trees that had the potential to block off the trail or injure hikers and bikers. We are excited to continue this work this coming season!

BLM TO HOLD MEETINGS REGARDING ALASKA LONG TRAIL STUDY

PARTICIPATE The Bureau of Land Management Alaska (BLM-A) is hosting five public meetings in April to



help determine whether to recommend naming the Alaska Long Trail (AKLT) as a National Scenic Trail (NST).

BLM-A is conducting a feasibility study to evaluate the characteristics of the work-in-progress Alaska Long Trail (AKLT) to determine its eligibility as an addition to the National Trails System. Results of the trail study will be shared with Congress, which has the sole authority to enact legislation to

designate new NSTs. Following that, rights-of-way, authorizations, and easements must be secured for the entirety of the route. Only after completion of that process could construction begin on the project. This feasibility study does not authorize any activities. WATCH FOR BIRD NESTS WHEN WORKING ON TRAILS

Trail work sometimes requires downing trees or clearing shrubs. When doing so, make sure not to violate



the Migratory Bird Treaty Act, which makes it illegal for anyone to "take" migratory birds, their eggs, feathers, or nests. "Take" includes destroying or damaging active bird nests or eggs. Different areas of the state have different sensitive periods generally occurring between April 15 and July 25. However, if you encounter an active nest at any time, leave it in place and protected until young hatch and depart. "Active" is indicated by intact eggs, live chicks, or the presence of an adult on the nest.

ALASKA STATE PARKS POSITIONS CAN INCLUDE TRAIL WORK

Alaska State Parks has a variety of seasonal positions through the Alaska Conservation Corps (ACC),



which are paid jobs, and its volunteer program. Tasks will vary and may include trail work, maintenance, fee station, or office work. Most positions begin in late May or early June. Some offices will start recruitment as early as March. HELP SLOW CLIMATE CHANGE: JOIN OUTDOOR ALLIANCE, COMPOST

Climate changes affects everyone, including trail lovers.

For winter trail lovers, a warming climate can mean shorter snow seasons and more extreme events like snow droughts and rain-on-snow events. For summer trail lovers, climate change can bring more droughts, wildfires, flooding, and permafrost thawing, all of which can hurt trails and the lands through which they run. These impacts will just get worse unless we slow climate change, which means we need to reduce our greenhouse gas emissions.

Here are two things you can do right now to help make a difference.

Join Outdoor Alliance

Outdoor Alliance is a nonprofit coalition that mobilizes outdoor enthusiasts to protect public lands and waters. This includes, but is not limited to, climate change.

The coalition is made up of several national advocacy organizations, including Winter Wildlands Alliance, the Mountaineers, the American Alpine Club, American Canoe Association, and the International Mountain Bicycling Association. The group also relies on individuals.

According to Outdoor Alliance, "Public land and conservation policy is complex, and we know how to effect meaningful change. We do the hard work, ensuring that we're not just talking but making a measurable impact on all public lands and



waters. That means building relationships with decision makers, enthusiasts, and activists to preserve

trails, create new legislation, share maps, and empower others to protect the places in their backyards and beyond."

REMEMBER TO VOTE IN THE ANCHORAGE MUNICIPAL ELECTION

VOTE Voting has already started for the Anchorage Municipal election. The last day to vote is April 2. If you have not voted already, make sure your voice is heard. The following is from an Anchorage Park Foundation email.

Vote Yes on Prop 4 Parks Bond The Municipality of Anchorage manages 11,000 acres of parkland, 226 parks, more than 250 miles of trails, and recreation facilities across the city. All parks and most park



facilities are free for the public to use. Costs for renovations of existing facilities and development of new facilities are funded primarily through bonds that require voter approval.

Proposition 4, the 2024 Parks Bond, would provide \$4.35 million for improvements to our parks, trail, and recreation facilities and leverage another \$16 million in federal match. The Parks Bond provides an affordable way to invest back into our community through the parks and trails that make Anchorage a great place to live, learn, play, and work.

Other bond measures with projects that benefit trails:

Proposition 3: Anchorage Roads and Drainage Bond

The Anchorage Roads and Drainage Service Area Roads and Storm Drainage bond includes a proposed project to add wayfinding signage that would point to the two major trailheads in downtown Anchorage, the Ship Creek Trail and the Tony Knowles Coastal Trail.

Proposition 9: Chugach State Park Access Service Area Bonds

The proposed Chugach Access Service Area (CASA) bond, if approved by voters, would provide \$4 million to upgrade Canyon Road and parking for popular trailheads leading to southside Flattop and Rabbit Lake. CASA Fact Sheet



CHUGACH MOUNTAIN BIKE RIDERS

In January 2024, non-motorized advocates successfully championed extending the separated bike path on



Construction was slated to begin in 2025.

In February 2024, AMATS (Transportation) staff proposed cutting the entire \$60M road/path project (paid for 90% with Federal dollars) and shift funds from Chugiak-Eagle River to Anchorage Bowl road projects.

Over the past decade approximately \$60M has been invested in Anchorage Bowl pathways, and zero funds have been spent in Chugiak-Eagle River.

Our vision is to connect the Moose Loop in Anchorage to outlying communities, including a path along the Glenn Hwy to Eklutna, and a

path to the Nature Center along Eagle River Rd.

TRUST NEEDS DONATIONS FOR LAND, TRAILS IN CHENA RIDGE AREA

Great news! There is the chance to expand the upland trails in the Isberg Recreation Area, off Cripple

Creek Road! And the Interior Alaska Land Trust (IALT) needs your help!

The Isberg Recreation Area (blue outline in graphic) has been growing in popularity in recent years, largely because it has some of the best winter trails in Fairbanks. But it also offers some rare upland trails on Chena Ridge for both summer use and the chance to get above the inversion in the winter. Now we have a chance to expand those trails and connect some loops.

The IALT has come to a purchase agreement to buy 90-acres of (mostly) upland forest (yellow outline in graphic) on the edge of the Isberg Rec Area, which will expand the

trails and make an existing loop trail much better. The trail currently follows a section line on a powerline that goes straight down the hill. I'm a good skier, and it's a terrible trail. With this parcel acquisition, the trail can be moved to a more reasonable alignment, making a much better experience. On the included map, the parcel, known as Graceland Estates, is outlined in yellow, and the Isberg Rec Area is outlined in blue.

Land acquisition, and building out greenspaces in general, is a somewhat messy patchwork.

Graceland will be a piece of a puzzle. But the IALT has been working for years on this and other places in

the Fairbanks area. (While the land trust is not a trails-specific group, it does recognize the importance of trails so that people can use and connect with land preserved for greenspace.)

ADVOCACY SECURES CONSISTENT FUNDING DESPITE CHALLENGES

Because of the efforts of the trails community including organizations, advocates, and user groups, funding for trail-specific line items in the Fiscal Year 2024, Interior and Related Agencies appropriations will largely remain level year over year, when many other programs and overall land management funding is facing steep cuts.

While trails and public lands still don't receive anywhere close to the funding fully needed to fulfill staffing, conservation, or maintenance mandates, the trails community recognizes the position of congressional appropriators and staff to make difficult funding decisions in the current climate. We express our appreciation that the value and importance of trails was recognized in this process to the extent that circumstances allowed.

While the topline cuts to federal land management agencies, insufficient staffing levels, and the zeroing out of funding for the Active Transportation Infrastructure Investment Program within the Department of Transportation will negatively impact the experience of all trail users, the trails community remains dedicated to supporting robust funding for federal land management agencies going forward and ensuring that conservation and recreation receives the funding it desperately needs and deserves.
