
Our next event will be on Wednesday, November 15,

# VIRTUAL RACE ACROSS ALASKA BENEFITS YOU AND ALASKA TRAILS

ENTER/DONATE The Race Across Alaska Winter Challenge, a multi-sport challenge, is a great way to get



outside while challenging yourself to stay happy and healthy during winter. And you can also be helping our cause to help build and maintain some of the best trails in the world!

Here's how it works. You can run, walk, fatbike, indoor bike, XC ski, swim, or any activity you like. You can choose from eight different virtual distances – from 60 miles to 2,000 miles, which is a whopping 22.3 miles per day. Now that's a challenge. The goal is to log as many miles as you can over the three months of winter to get (virtually) from location A to B. You can also participate as a team (friends/family/school).

You will have the ability to log your miles, track your progress, collect virtual badges, and see how you rank up to others on the leader board daily. You can invite others to this challenge to help you to stay motivated all winter long.

Oct 25: Alaska Trails is grateful to be a National Forest Foundation grantee in the Chugach National Forest!

These funds have been used to make essential improvements to the Johnson Pass Trail. The Alaska Trails crew greatly improved sections by adding drainage structures, widening the corridor through brushing, and reestablishing the grade, giving trail users a more enjoyable experience. This section of trail will be more fun for mountain bikers and hikers alike since the mucky, in-sloped sections of trail have been regraded and drainage structures added, giving the water someplace other than the trail surface to run to. Since the corridor was cleared of brush, debris, and hazard trees, trail users have better sightlines,



allowing for a safer experience on the trail avoiding potential close-up wildlife encounters or fast-moving mountain bikes.

The Johnson Pass trail was built in 1907 as a wagon road linking Seward to the growing communities of Sunrise and Hope and it serves as a segment in the Iditarod National Historic Trail. By keeping this trail open, clear, dry, and sustainable to trail users, it preserves a part of Alaskan history.

# NEW WEBSITE SET UP FOR SNOWMACHINE TRAILS PROGRAM

The Snowmachine Trails Program now has a new website and increased funding.

This summer the program transferred from the Department of Natural Resources (DNR) to the State of Alaska Department of Transportation (DOT&PF). You can see the new website here: <a href="https://dot.alaska.gov/snowtrails/program.shtml">https://dot.alaska.gov/snowtrails/program.shtml</a>

In early October, Adison Spafford, Community Resiliency Coordinator for DOT&PF, sent an email about the new website and program:

We continue to work on stabilizing the new program and understand there may be changes or questions regarding the new administration of the program. Please send any questions or comments you have directly to me. You can also send/copy emails to the snowtrails email inbox @ dot.snowtrails@alaska.gov for the record (several people check this inbox to help us ensure timely responses).

We will be working to establish the SnowTrac
Advisory Council and process for evaluation of
applications. Information regarding the SnowTrac
Advisory Council will be added to the website when available.



According to an earlier press release from DOT&PF, transferring the program "will allow the DOT&PF to explore options to enhance the program funding and eligibility projects for the grantees through leveraging other potential funding sources and partnerships."

In addition to the new transfer and new website, the program also has increased funding. According to Spafford, the funding will go up to about \$750,000 from the previous \$150,000 or so that it was under DNR. Base funding for the program comes from snowmachine registration fees.

# COMMENTS DUE IN NOVEMBER ON STATE ATV/UTV PERMIT DECISION

The deadline is November 20 for comments on the amended decision to issue a statewide General Permit (GP) for All-Terrain Vehicles (ATV) and Utility Terrain Vehicle (UTVs) with a curb weight between 1,500 and 2,500 pounds for use on DMLW managed lands.

DMLW determined that the public interest would be served by issuing a General Permit (GP) authorizing use of ATVs and UTVs that exceed the GAU limits. The amended decision eliminates the term Recreational Off-Road (ROV) vehicles and clarifies the criteria.

The permit authorizes the use of ATVs and UTVs on general state land provided they meet the following criteria: 80 inches or less in width; having a curb weight of 2,500 pounds or less; and designed to travel on four or more non-highway tires.

This GP authorizes ATVs and UTVs to travel upon general state land without requiring a separate authorization as long as the vehicle use adheres to the conditions set forth in the GP: (1) activities employing ATVs and UTVs must be conducted in a manner that minimizes surface damage; (2) vehicles must use existing roads and trails whenever possible; (3) activities must be conducted in a manner that minimizes (A) disturbance of vegetation, soil stability, or drainage systems; (B) changing the character of,

polluting, or introducing silt and sediment into streams, lakes, ponds, water holes, seeps, and marshes; and (C) disturbance of fish and wildlife resources.

Use of any motorized vehicle outside of the above criteria on state land requires an authorization from DNR. The GP is not valid for ATV and UTV use on private land, state parks, legislatively designated areas, or land owned or managed by other state agencies such as the University of Alaska, Alaska Mental Health Trust, Department of Transportation and



Public Facilitates, or the Alaska Railroad. Some special use areas may also restrict off-road vehicle use.

Issuance of the GP does not alleviate users from obtaining a Fish Habitat Permit from the Alaska Department of Fish & Game, Habitat Section for crossing waterbodies if needed.

Nothing in the decision restricts DNR-DMLW authority to require a land use authorization for any ATV or UTV use if deemed necessary for the protection of state land and resources. Based on feedback received from the public on the original decision, DMLW is providing an opportunity for the public to comment on the issuance of the amended decision and GP.



# RESOURCES HELP REDUCE PET/TRAPPING CONFLICTS

Trapping season opens November 1, so trail users who let their dogs run loose should make sure they



know some basic information about traps and trap lines. A pamphlet and videos are available.

<u>PAMPHLET</u>: A pocket-sized pamphlet titled "Trap Safety for Pet Owners" describes the types of traps and snares that may be encountered and provides illustrated instructions on how to free pets swiftly and safely. It is produced by the Alaska Department of Fish and Game (ADF&G) and the Alaska Trappers Association (ATA). Copies are available free of charge at department offices or may be viewed on the website at: <a href="http://tinyurl.com/m6oulhk">http://tinyurl.com/m6oulhk</a>. More information, including video footage featuring trap removal instructions, is found on the department's website at <a href="https://www.adfg.alaska.gov">www.adfg.alaska.gov</a> (see "Sharing the Trails" under the

<u>VIDEO</u>: The ATA also sells a 30-minute video, "Sharing Alaska's Trails," that includes information such as how to know if you are on a trap line, trap line safety, the physics of handling and opening traps and



snares, and tips for first-aid for pets accidentally caught in traps. The video doesn't promote trapping but deals with the practicalities of sharing the trails. A three-minute excerpt of the DVD can be found on YouTube (www.youtube.com/watch?v=Jk242iZwEAQ). To order a copy of the DVD check the ATA store (www.alaskatrappers.org).

Most trapping seasons run from November 1 to the end of February, but the season for a few species lasts longer. Wolf traps could be active well into April.

# WINTER TRAIL GROOMING PROGRAMS NEED YOUR HELP


DONATE/SERVE Winter is upon us and if there is no snow on the ground in your area, there soon will be.

Many winter trail activities require (or at least are much improved by) grooming, such as snowmachining, skiing, mushing, and fatbiking. If you

engage in an activity that is improved by grooming, please remember to support those efforts. There are several ways you can help.

If you use an area that is clearly groomed and has a grooming fund, make sure to donate. Not all trails that are groomed have a specific grooming fund, but you can also join or donate to the group that is doing the grooming. Look for signs that tell you how you can help.

You can also support the Alaska Snowtrail Grant Program, which provides funds for grooming in several areas of the state. The grooming this program provides benefits more than snowmachiners. Anyone who uses the groomed trails benefits, including fatbikers, skiers, mushers, and hikers. You can't donate to the Snowmachine Trails Program, but you can help it by making sure to register your snowmachine, which is what funds the program. You can also serve on the SnowTRAC board, which advises the state administration on how the funds are spent. Finally, you can



advocate for the program. In years past, administrations have tried to cut the program as part of budget cutting measures. However, strong advocacy has kept the program alive.

GPRA's impact on local outdoor recreation has been massive and is drawing people from all over Alaska to experience the first rate trails, so meticulously groomed by the Mat-Su Ski Club. ### ALASKA DOG MUSHERS ASSOCIATION

Oct 25: We've been getting some calls and questions about trail grooming. Just a friendly reminder that per our permits and regulations, we cannot begin grooming until there is at least 9" of snow on the ground, and realistically need about 18" before the grooming is effective in filling in the holes and tussocks on the trail.

The earliest we usually start to groom is early November, so with some more snow and cold weather Carl should hopefully be back at it soon! The snowmachines are all serviced up and ready to go, just waiting on the ground to freeze solid (it wasn't yet when we plowed the other day) and a little more of the white stuff.



Don't worry, we are as excited as you to get back on the trails but want to make sure it's done in the best way possible and sometimes that means waiting a bit!

### TWO RIVERS ALASKA SKI TRAILS

Oct 24: The Two Rivers Ski Trails group are few in number. We own a 2010 Skandik and some grooming equipment that we are responsible for maintaining. We do this with donations. We donate our time on the machine.

During the winter of 2022 to 2023 we received donations for fuel from Two Rivers School, and from one other donor. It totaled less than \$150.00.

This year the Skandic is in need of a new Voltage regulator, oil sensing unit, and some put off maintenance (track adjustments for one). The tab is approaching \$1,000 and we do not have the funds.

I am reaching out to the community of users and people who believe the Two Rivers Ski trails fill a role in this community. I see people on the trails, I know some of the users have never donated for trail maintenance. It is time to for you to step up.

Can we get the users of these ski trails to help us out in a big way? We need the machine in order to have groomed trails. Without the machine, there is no grooming.

We also need volunteers to run the machine around the trails, after each snow and in between snowfalls as needed. The job involves lifting heavy equiptment and being able to stay outside and warm for three to four hours.

Without your donations, there will be no groomed trails.

Yes, we have snow, but the creeks and rivers are not completely frozen yet! Ice has covered most of the ponds, but they are still unsafe for human travel.

The snow depth varies from 3-6 inches depending on where you are. The trailheads and cabin driveways are accessible and in good condition.



# LEGACY TRAILS GRANT PROGRAM APPLICATION PORTAL NOW OPEN

APPLY American Trails is pleased to partner with the U.S. Forest Service in continuing the Legacy Trails Grant Program. This program is funded through the Bipartisan Infrastructure Law and supports partner trail projects that further the Legacy Roads and Trails criteria on National Forest System trails throughout the nine Forest Service Regions. The goal of the program is to support projects that restore, protect, and maintain watersheds on our national forests and grasslands. American Trails is administering this grant program, and is soliciting applications for funding, with awards up to \$100K per project. The application portal is now open! The deadline for applications is December 1 at 11:59 pm Pacific.

Project applicants may include nonprofit organizations, businesses, or agencies at the state or local level. The Forest Service identifies and prioritizes watershed acres or areas where Forest Service roads and trails may impact water quality in streams and water bodies. Protecting threatened, endangered, and sensitive species, and community water sources are among the top priorities for projects that improve and maintain trail access. Emergency operations, such as evacuation routes during wildfires, floods, or other natural disasters also benefit from this program.
